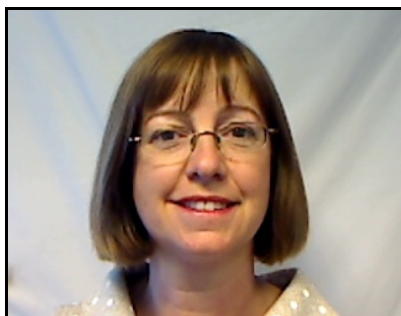


## **MEMBERSHIP OF CARMEL COLLEGE GOVERNING BODY 2017-2018**
